


We hire veterinarians to provide free and low cost veterinary services to low income pet owners. This is the major part of our efforts at this time. In 2014 we treated 4,686 low income household pets. We also provided free veterinary services for NYC Animal Control animals at the rate of 11 % of our net income. In addition we provided free services to low income pet parents at the rate of 24.3 % of our net income, and 8.3 % of our gross program revenue. Together, our total free services amounted to 35.3 % of our net revenue and 12.1 % of our gross revenue in 2014. As a result hundreds of NYC Animal Control animals were treated for free, including expensive surgeries, which made them adoptable into new homes rather than each animal costing NYC \$200 to intake, process, evaluate, board, and either adopt or euthanize. We held two totally free full veterinary service days for victims of Superstorm Sandy.
