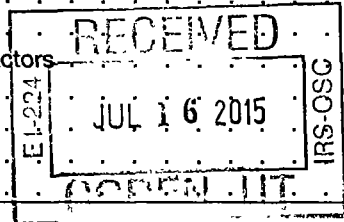

A 2nd ITMIG supplement to the Journal of Thoracic Oncology was published in September, 2014. This marks

another milestone for ITMIG in working to create foundations for collaboration as well as to foster better care for

patients around the world. The supplement features the proposals for the first official stage classification system

for the 8th edition of the AJCC/UICC stage classification manual, which are due to take effect in 2016. This is the

result of a partnership between IASLC (International Association for the Study of Lung Cancer) and ITMIG, and a

three year effort by the Staging and Prognostic Factors Committee. The supplement also has several articles with

practical guidance on approaching patients with anterior mediastinal masses as well as review articles on

particular immunologic, neurologic and genetic features of thymic malignancies.

5Th Annual Meeting

The 5th ITMIG Annual Meeting took place in Antwerp, Belgium, between September 5th and September 6th, 2014

at the Elzenveld Hotel & Seminaire, an historic convent in the center of Antwerp. The conference, a 2-day

meeting with more than 110 delegates, was superbly organized by Dirk Van Raemdonck and Paul Van Schil,

Belgian Thoracic Surgeons, on behalf of the European Society of Thoracic Surgeons (ESTS) and the European

Association for Cardio-Thoracic Surgery (EACTS). Several invited lectures, along with 16 Oral Abstracts and

38 Posters displaying original research were featured at this Annual Meeting.

Cancer Genome Atlas

ITMIG has supported the Cancer Genome Atlas (TCGA), which is an NCI sponsored initiative aimed at genomic analysis of tumors. ITMIG was

instrumental in getting TCGA to include a rare disease such as thymic tumors, and contributed all of the specimens to the project.

This initiative would not have been possible without ITMIG. This will now enable us to perform more research based on the TCGA results,

• which will be available at the end of 2015.
