Completed the construction of the Mnindi Primary School in the Vigwaza Ward, Bagamoyo District, Tanzania. The completed school has a total of seven classrooms (one completed in 2013), 2 offices, 2 staff houses for 4 teachers, and an eight stall latrine. The Grand Opening was held on December 11, 2014 and the school was officially handed over to the Honorable Dr. Shukurn Kawambwa, Minister of Education and Vocational Training and Member of Parliament for Bagamoyo, Tanzania constituency.

We also provide educational opportunities for English and computer skills to local Primary School teachers and the parents and relatives of the SES members.

We pay for the four teachers, a cook, the food, school fees, uniforms and the rent on the school and office space. We also cover emergency medical care for the children and teachers.
