Last year, Dalton Whitfield County Housing Authority (DWCHA) asked us to partner with them to provide Emergency Shelter to people who met DWCHA's criteria. Our CEO/Pres. Robert Hill takes care of getting them into temporary (a weekend at a time) housing and DWCHA reimburses us ~~for~~ the amount. It is an extension of our services, but DWCHA considers it a grant and therefore we note it separately.
