THE INSTITUTE FOR CHILD SUCCESS (ICS) IS A NONPROFIT ORGANIZATION ESTABLISHED IN RESPONSE TO ALARMING DATA ABOUT THE FAILURE OF SOUTH CAROLINA'S CHILDREN IN MEETING EVEN THE MOST BASIC MEASURES OF ACADEMIC SUCCESS AND WELL-BEING. THE INSTITUTE IS UNIQUE, HOWEVER, IN THAT WE ARE NOT FOCUSED ON ANSWERING THE QUESTION OF HOW THESE CHILDREN HAVE FAILED WITHIN OUR SYSTEM. RATHER, THE INSTITUTE IS COMMITTED TO ADDRESSING HOW OUR SYSTEM HAS FAILED SO MANY CHILDREN. SEE SCHEDULE O FOR CONTINUATION. ICS HAS ENJOYED CONSIDERABLE MISSION SUCCESS IN ITS SHORT HISTORY AND OUR WORK IS IMPACTING THE EARLY CHILDHOOD SYSTEM THROUGHOUT SOUTH CAROLINA AND BEYOND. ICS ACCOMPLISHMENTS OVER THE PAST YEAR INCLUDE SCHOOL READINESS LEGISLATION. ICS WORKED WITH NUMEROUS STAKEHOLDERS TO CRAFT LEGISLATION TO REFORM AND REAUTHORIZE SOUTH CAROLINA FIRST STEPS TO SCHOOL READINESS. THIS LEGISLATION WAS PASSED AS LAW IN JUNE 2014. THE LEGISLATION INCLUDES A DEFINITION OF "SCHOOL READINESS" AND ESTABLISHES THE OFFICE OF FIRST STEPS STUDY COMMITTEE, WHICH WILL MAKE RECOMMENDATIONS ABOUT THE FUTURE STRUCTURE OF STATE-FUNDED EARLY CHILDHOOD PROGRAMS. IN 2015, EARLY CHILDHOOD DESIGN THINKING BLITZ: MORE THAN 40 DESIGN THINKERS AND EARLY CHILDHOOD PROFESSIONALS FROM ACROSS THE UNITED STATES CAME TOGETHER IN GREENVILLE FOR A THREE-DAY EARLY CHILDHOOD DESIGN THINKING BLITZ TO EXPLORE THE APPLICATION OF DESIGN TO ADDRESS PROBLEMS PLAQUING EARLY CHILDHOOD SYSTEMS. DESIGN THINKING IS A NEW WAY OF SEEKING SOLUTIONS TO CHALLENGES IN GOVERNMENT, BUSINESS, THE SOCIAL SECTOR, AND HEALTH CARE THAT CAN HELP CRAFT SYSTEMS THAT ARE MORE EMPATHETIC AND RESPONSIVE TO THE NEEDS OF CHILDREN AND FAMILIES. PAY FOR SUCCESS (PFS) FINANCING: ICS IS WORKING TO BRING PAY FOR SUCCESS FINANCING MECHANISMS TO THE EARLY CHILDHOOD SECTOR. PFS FINANCING IS AN INNOVATIVE TYPE OF PUBLIC-PRIVATE PARTNERSHIP THAT EMPLOYS PRIVATE CAPITAL TO INVEST IN SOCIAL PROGRAMS THAT HAVE PROVEN SUCCESS. AS PART OF THIS WORK, ICS CONTINUES TO LEAD EFFORTS TO BRING PFS FINANCING TO SOUTH CAROLINA. BASED ON WORK ICS INITIATED IN 2013, NURSE-FAMILY PARTNERSHIP IS WORKING WITH THE SOUTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES TO DEVELOP A PFS MODEL TO DRAMATICALLY EXPAND HOME VISITING FROM 900 TO 4,860 FIRST-TIME, LOW INCOME MOTHERS AND THEIR BABIES. CONTINUED EXPANSION OF 4K: 2,380 ADDITIONAL CHILDREN IN SOUTH CAROLINA WERE PROVIDED THE OPPORTUNITY TO ATTEND FOUR-YEAR OLD KINDERGARTEN (4K). MANY LEADERS CITE EXPANSION OF PUBLICLY-FUNDED 4K IN SOUTH CAROLINA AS A DIRECT RESULT OF ICS'S FRAMING OF THE ISSUE AND WORK WITH BUSINESS LEADERS AND MEMBERS OF THE GENERAL ASSEMBLY. THIS INCREASES THE NUMBER OF CHILDREN ABLE TO ATTEND 4K IN SOUTH CAROLINA'S POOREST 61 SCHOOL DISTRICTS TO 8,282. EARLY CHILDHOOD RESEARCH SYMPOSIUM: ICS BROUGHT TOGETHER 160 PROFESSIONALS REPRESENTING ACADEMIA, HEALTH CARE, GOVERNMENT, AND SERVICE PROVIDERS AT THE INSTITUTE'S SECOND SOUTH CAROLINA EARLY CHILDHOOD RESEARCH SYMPOSIUM. THE SYMPOSIUM EXPLORED THE LATEST EARLY CHILDHOOD RESEARCH WITH A FOCUS ON CONNECTING RESEARCH, POLICY AND THE COMMUNITY TO BUILD A STRONGER EARLY CHILDHOOD SYSTEM IN OUR STATE. SOUTH CAROLINA EARLY CHILDHOOD ANNUAL DATA REPORT: ICS DEVELOPED THE SOUTH CAROLINA EARLY CHILDHOOD ANNUAL DATA REPORT THAT AGGREGATES DATA ON THE FAMILY ENVIRONMENT, PHYSICAL HEALTH, EMOTIONAL WELL-BEING, AND COGNITIVE DEVELOPMENT OF YOUNG CHILDREN ACROSS OUR STATE. BY CENTRALIZING ALL EARLY CHILDHOOD DATA IN ONE PLACE, THE INFORMATION THAT IS COLLECTED BY MANY DIFFERENT AGENCIES BECOMES MORE ACCESSIBLE AND USEFUL FOR STAKEHOLDERS, PROPELLING INDIVIDUAL AND COLLECTIVE ACTION TO IMPROVE THE EARLY CHILDHOOD SUPPORT SYSTEM IN SOUTH CAROLINA.
