Objective: To change attitudes towards farming and encourage adoption of intensive farming practices in the country of Niger. The program targets mothers in the community and students in the local schools. Students receive a combination of classroom and experiential learning. The mothers participate in profitable and self-sustaining agribusiness ventures. Program design was completed in 2011. A four year field test started in 2012. This project has been included in all 990 reporting years.

2014 Accomplishments: We added a fourth village to our pilot program and continued to refine the model to increase effectiveness, reduce cost, and simplify implementation. As part of the simplified classroom program, a

Objective: To test a model to provide affordable extension agent services to rural farmers in Africa. The Lead Farmers Program organizes farmers into associations of approximately 100 each. Each association elects a "lead farmer" to work directly with an extension agent to apply best agricultural and business practices to maximize farm income. The "lead farmer" is responsible for sharing those practices and encouraging their adoption with all members of the association. The program is being tested with smallholder farmers in Mayange, Rwanda in partnership with the Millennium Villages Project. The project was new in 2013.

2014 Accomplishments: Now in its second year, this innovative program is

Objective: To provide low interest loans to women graduates of the Songhai Centre to start up their own farming ventures. The goal is to showcase what talented and motivated women can do when given the training and opportunity. They become role models for others to follow, increasing female enrollment in the prestigious Songhai Centre and changing the perceived role of women in society. The program was listed in the 2011, 2012, and 2013 FORM 990.

2014 Accomplishments: In 2014, 7 new loans were awarded, doubling the number of women participating in the program. Women receive low interest loans from \$600-\$6,000 to start their own farm businesses. Equally

LITTLE ROCK SCHOLARSHIPS AND TUTORING PROGRAMS

Objective: Provide 4 year scholarships to secondary boarding schools for graduates of the Little Rock School located in Kibera, the largest slum in Kenya. The program also pays for the tutors to work with students during their primary school years to improve their academic performance and chances of winning scholarships. The program has been included in the 2011 through 2013 Form 990.

2014 Achievements: Ten new scholars entered 9th grade and an additional 10 scholarships were awarded for students entering secondary school beginning Q1 2015. This brings the total number of scholarships awarded as of December 2014 to 26. In addition to the after school tutoring program for primary school students we have added a tutoring and mentoring program for our scholarship winners. Our scholars face a huge adjustment to secondary boarding school: being away from home for the first time and sleeping in a bed for the first time, being the "kid from the slums" in schools attended mostly by kids from middle class families to name just a few. Most students are adjusting well. Of the 16 students who have completed at least 1 full academic year, half are in the top 20% of their class, several are in the top 5%, and one is in the top 1% of her class.

Objective: To provide funds for the Little Rock Early Childhood Development Centre school feeding program. Students often come to school hungry and the school lunch is usually the only nutritious meal the students can depend on. Getting fed at school enables them to concentrate on their academic
