In 2013 ASCF awarded two grants to Ilisagvik College, the first to help with the Inupiat Summer Immersion Camp (8 youth and 4 elders participated) designed to give participants a life-changing event that will magnify their knowledge and appreciation of the Inupiaq ways of living We are confident that, as intended, the eight (8) participants will take a more active role within their families and communities to preserve our vital heritage and language The second for the Science in Culture Context "Changing Permafrost in the North Slope"(3 elder, 9 students and 5 scholars) where the youth engaged in exploration of scientific fields as well as their environment, demonstrating relevance to their culture, their communities and their future, ultimately encouraging youth advocacy and increased participation of local youth in college level academic programs, improving in the near and long-term the creation of local labor pool of qualified scientists, technicians and educators Grants were also given to the Native Village of Barrow to help purchase search and rescue equipment, whaling equipment and food supplies for the local food bank, and to Kaktovik Community Foundation to support a new community ice cellar

Also, ASCF works with other local communities and organizations to provide support and cultural impact. Attraction of Public Support - We have a continuous and bona fide program to seek public support from the general public, governmental units and charities. Our staff research and submit grant applications from corporate and foundation funders. Representative Governing Body - Our board represents broad public interest and includes representatives from business and the people of the arctic slope.
