


CHILD SPONSORSHIP PROGRAM: BY RECRUITING AND MANAGING SPONSORS FOR THE CHILDREN IN OUR FIVE PARTNERED AFTERCARE HOMES WE ARE ABLE TO ENSURE THE DAILY NEEDS OF THESE RESCUED VICTIMS ARE MET. WE LAUNCHED THE PROGRAM AT THE END OF SEPTEMBER AND BY THE END OF THE YEAR HAD RECRUITED APPROXIMATELY 40 PEOPLE TO MAKE SPONSORSHIP COMMITMENTS.
