Food for Families program - Groceries are provided to families identified as at-risk by various social organizations and public school system counselors. Recipient groups include refugee families or groups that have relocated to the community.

Revenue of \$96,700 is the value of perishable and non-perishable groceries donated by community citizens, collected and distributed by PORCH. Expenses include this same value plus \$105,772 received as general donations used to purchase produce and other groceries also distributed to the recipient families.

Donations to local food pantries program - Groceries are provided to local area food pantries, churches, Meals on Wheels, a historic neighborhood association and Department of Social Services.

Revenue of \$78,360 is the value of perishable and non-perishable groceries donated by community citizens, collected and distributed by PORCH. Expenses include this same value plus \$1,273 received as general donations used to purchase produce and other groceries also distributed to the recipient organizations.

Donations to local school food program - Food items are purchased and distributed by PORCH to local area schools for counselors to distribute to students in need during school hours.
