The mission of HKF is to bring reliable and sustainable healthcare to the people of Kajo Keji, South Sudan. In 2013 HKF opened a clinic (three 40-foot containers fully equipped) which is operated by local doctors and staff. Our mission was accomplished in 2014 by a small team of doctors and other personnel who traveled to South Sudan to hold medical clinics in villages and at the clinic and work with water purification and the clinic roof. We also raised funds in the US for the support of the clinic and staff.

Salaries of doctors and staff at the clinic in Kajo Keji, South Sudan. The Healing Kadi Foundation raises funds to cover the salaries and wages of the doctors, nurses, pharmacists, and other personnel who operate the clinic in South Sudan that opened in June 2013. Although there were few gifts designated for salaries of the clinic personnel, the general funds covered the cost. The clinic in South Sudan is responsible for all local and governmental taxes as well as the retirement amount. The goal is for the clinic to become self-sustaining.

4b (Code:) (Expenses \$ 30,341 including grants of \$ 0) (Revenue \$ 26,710)

Medicine Drive: Through the local CVS stores, the Healing Kadi Foundation promoted a medicine drive through several activities in schools, churches, and community events which raised both money to buy medicines and medicine being donated. Some of the medicine was shipped to the clinic directly and some was taken in duffel bags by a volunteer to South Sudan. All revenue received for medicine was used to buy the medicine that was sent to the clinic in Kajo Keji.

4c (Code:) (Expenses \$ 7,627 including grants of \$) (Revenue \$ 10,425)

Mission Trip to Kajo Keji, South Sudan: Several doctors traveled to South Sudan at different times throughout the year to provide medical care both at the clinic and in the surrounding villages. Other volunteers also traveled there to finish the clinic roof and the water purification system which also provides water for the surrounding community. The amount of revenue over the expenses was used in 2015 for the Mission Team that travelled there in March 2015.
