Raven Rock Ranch uses horses to give mental health therapy to traumatized children so they can develop successful relationships with parents, peers and teachers. The families and children who benefited were approximately 300.

Raven Rock Ranch does not charge for any therapy sessions. One full time Equine Facilitated Therapist and one instructor were hired to accommodate the growing need. Raven Rock Ranch has approximately 45 volunteers and 8 horse counselors.
