Friends of Amani US Inc funds have been granted to Amani Centre for Street Children to support their ongoing operations and capital projects. Amani successfully continues rescuing homeless children in Tanzania and providing them with nurturing care - education, nutritious food, essential medical care and a compassionate staff of teachers, social workers and care-givers dedicated to their well-being - which will restore hope in the lives of these most vulnerable members of the community, helping them to one day become self-sustaining independent young adults and contributing members of society. Our Board has also seen very positive indications that Amani is planning for its own viable and sustainable future as evidenced by their impressive sound fiscal management. All funds currently held by Friends of Amani US Inc have been approved to be granted to Amani Centre for Street Children as long as this committed organization continues meeting our Board-approved funding criteria and the expectations and intent of our donors, which our Board ensures with ongoing oversight and follow-up.

Monthly Sponsorship Program - A sustainable source of revenue is the very successful Monthly Sponsorship Program where Friends of Amani US Inc reaches out to donors and an agreement is made to sponsor the Amani children on a monthly basis. This arrangement provides a reliable, ongoing source of income that is predictable and assists with maintaining a budget. The minimal cost associated with this program is for staff time to process and acknowledge donations as well as for donation processing fees charged by PayPal and the bank.

Volunteer Fundraising Program - Friends of Amani US Inc has a supportive group of volunteers who reach out to family and friends in their own communities and beyond on behalf of the Amani children. This has become a vital source of ongoing funding with minimal expense to the organization. Amani's location at the foot of Mt. Kilimanjaro provides an ideal opportunity for volunteers to travel to Tanzania, climb the mountain and spend time volunteering with the children; all while raising support on their behalf. Whether climbing or not, volunteers set up webpages with online fundraising sites, write personal appeal messages outlining their reasons for supporting the Amani children, and hold special events, all to raise awareness of the issues of poverty and homelessness in Tanzania, introduce their friends to Friends of Amani US Inc and our collective choice to support Amani Centre for Street Children and their wonderful programs designed to change the path of life for these extremely vulnerable and all too often marginalized members of the community. To know Amani is to realize their work is vital and real. The expenses involved with the program are primarily for online processing fees and for staff time to support the fundraising efforts and ensure the program's continued success.
