POP Market (Pennies on the pound) - Connects agencies serving food-insecure community members with local food at an affordable price. This year we bought from dozens of farmers, sold to dozens of buyers, specifically nonprofits and social mission-driven businesses, and returned sales to local farmers.

4b (Code:) (Expenses \$ 82,532 including grants of \$) (Revenue \$)
Donation Stations collect fresh food and funds from farmers' market customers in order to buy food at farmers' markets for local agencies feeding the food-insecure. This year Donation Stations collected more than 57,000 lbs of fresh food to 35 agencies, reaching over 20,000 individuals.

Other Programs include "Farm to Children", which works with afterschool snack and weekend backpack programs to supply nutritious locally grown fresh food to children at risk for hunger (supplemented buying power for institutions feeding children, providing fresh food to over 2500 children regularly); "Farm to Family", which provides predictable amounts of fresh local food to families who are at risk for hunger or malnutrition and who can't easily access food pantries; and "Food Ambassadors", which provides fresh food education (developed educational materials).
