They look for those who are committed to the Christian faith and demonstrating community leadership or intentions towards creating healthy communities in all of their diversity/complexity. In 2014 approximately 30 Christian leaders from 24 different countries across the world participated in the program's cornerstone 3 month training effort in South Africa.

Enduring Fruit identifies, trains, and empowers individuals and organizations globally to promote Christian leadership and character skills, primarily through the use of sports activities and Level 1-3 trainings. No less than 2,000 individuals in 25 different countries took part in the trainings, empowerment, and compassion related projects completed by this program.

No less than 5,500 individuals took part in the trainings, empowerment, and compassion related projects completed by this program.
