The organization successfully raised \$1,806,220 primarily in late 2013 with the proceeds to be used for the medical care of the poor in Syna The funds as of December 31, 2013 have not been deployed and the organization has not incurred any expenses This is due to the civil war going on in Syna eliminating the original sources for the funds to be deployed and the inability to locate reliable avenues to deploy the funds The officers and Board of Directors are working deligently to find reliable avenues to deploy the funds as well as obtaining quotes for medical equipment which cannot be finanlized until such time it is safe to deploy the equipment The United States governement has also provided guidance indicating the need to delay the deployment of assets as per house Resolution 520 which passed
