Direct Investment and Advisory Services Elevate employs Entrepreneurs-in-Residence (EIR) throughout the state to provide direct support and advisory services to Indiana companies The EIR’s work directly with companies to provide mentorship, service and advisory referrals, and introductions to capital sources EIRs connect companies to potential business partners, service providers, investors, and talent Elevate EIRs participated in 3 “Startup Weekend” events, mentored teams through Notre Dame’s ESTEEM Lean Launchpad program and Business Plan Competition, presented Lean Startup methodology in classes, and established regional investor networks Elevate launched the Northwest Indiana Tech Foundry, a technology-sector business accelerator in Valparaiso The first cohort included 6 Indiana technology startups EIRs provided direct advisory consulting to over 360 companies helping them develop their director and advisory boards, hire management teams, connect with service providers, and a variety of other mentoring activities EIRs also refer companies into other programs, including Elevate’s Direct Investment and Economic Gardening programs Direct Advisory Services are operated through the Quickstart and Regional Entrepreneurial Action Plan (REAP) Programs Funding for the REAP and Quickstart programs come from a combination of grants from the Indiana Economic Development Corporation and direct contributions from stakeholders in the regions in which these programs operate Elevate’s EIRs also present companies to regional advisory boards who review and approve High-Potential Startup Grants, a program that awards small grants of \$5-25K to high-potential start-ups to enable attainment of measurable outcomes or milestones In 2014, a total of \$223,000 was awarded to a total of 12 companies Elevate’s Economic Gardening program is a 3-step consulting platform that guides and supports second-stage companies to help them achieve high growth at no cost to the company It allows such companies to access expert leadership, market research, and implementation consulting services that they may not otherwise be able to obtain Second-stage companies have between \$750K-\$25M in revenue and between 5-100 employees Most of the companies served had under \$5M in revenue and a median company size of 16 employees Elevate contracts with 3 vendors to provide the Economic Gardening program to second-stage companies The value of the consulting averages approximately \$5K per company with a maximum cost of \$8K This program currently operates in Northwest, North Central, Northeast and Southwest Indiana In 2014, 71 companies completed the program, and 62 companies were enrolled during the year Consulting services include market research services from the Edward Lowe Foundation, leadership assessment services from LeaderMarks, and Implementation services from AutoSolve Edward Lowe Foundation provides up to 36 hours of consulting services from a team of research specialists specializing in strategic market research, geographic information systems, search engine optimization and social media marketing Consultants identify market trends, potential competitors and unknown resources, provide geographic data for targeted marketing, increase search engine visibility and web traffic, analyze the competitive marketing landscape, and advise on core strategies and business models LeaderMarks provides Leadership Assessment of the company’s CEO and management team This is an optional additional service available to companies enrolled in Elevate’s Economic Gardening program On completion of the Edward Lowe Foundation’s market research consulting, companies may opt-in to receive up to 20 hours of implementation consulting from AutoSolve AutoSolve helps companies develop and implement plans to utilize the market research data from the Edward Lowe Foundation to increase revenue and grow their business The AutoSolve consulting services were added to the program based on feedback from the first 3 years of the program As a result of adding the expanded service, many companies who completed the program in 2011-2013 reactivated to take advantage of this new services Those companies were counted in 2014 results Direct investment Elevate Ventures was founded in 2011 to assist the Indiana Economic Development Corporation (IEDC) manage a portfolio of direct capital investments in high-potential Indiana companies and to make capital more accessible to Indiana entrepreneurs Through a subsidiary partnership with the IEDC, Elevate Manages 4 investment funds, the Indiana 21st Century Fund, Indiana Angel Network Fund, Indiana High-Growth Fund, and the Indiana Seed Fund Holdings The separately reportable partnership holds the investment capital and portfolio income/expense and reports earnings via the IRS Form 1065 U S Return of Partnership Income Elevate receives funding from the IEDC to manage these investment funds through a Professional Services Agreement and a Management Fee arrangement for the various funds In 2014, Elevate completed 24 investment transactions with a total of nearly \$8.3M invested, leveraging \$13M in co-investment from private investors Of those 24 transactions, 16 were new investments and 6 were follow-on funding for existing portfolio companies Since inception, Elevate invested over \$29M in 47 companies, 5 of which have exited successfully These investments leveraged an additional \$190M in private dollars, resulting in a 6.41 leverage ratio Annual payroll of the portfolio is nearly \$50M, employing 746 people with average salaries of nearly \$66K As part of Elevate’s efforts to build relationships between capital sources and companies, Elevate sponsored the Forbes Innovation Summit, the 6th Annual Innovation Showcase, 15th Annual TechPoint Mira Awards, and the Fort Wayne Innovation Awards Elevated hosted 2 Investor Roadshow events in Chicago and Indianapolis in order to facilitate one-on-one introductions of Indiana companies with potential investors Between 17 and 19 venture firms and 18 to 24 Indiana companies attended each of the 2 events and 169 one-on-one meetings took place Elevate, in partnership with IEDC, through the 21st Century Research & Technology Fund provides Phase I proposals with a support letter committing \$0.50 towards every federal dollar awarded, up to \$50K in state matching per federal award with a lifetime maximum of \$150K in state matching per company, including affiliates In 2014, 24 state matching awards to 21 Indiana companies were qualified, totaling \$1.165M in state matching dollars against \$4.367M in federal grants
