Request for Abatement of Late Filing Penalty

The 2014 Form 990 for Restore Innocence is being filed past the original due date of the return, without extension. The organization has been planning to change their fiscal year end to June 30. The organization was unaware that the change would not go into effect until they file a short period tax return. The tax return was filed immediately upon discovering that the 2014 return would still be due on May 15, 2015. The organization will be filing a timely short period Form 990 for the period January 1, 2015 to June 30, 2015.

The organization is a volunteer based not-for-profit that exists to aid victims of human trafficking, and any late filing penalty assessed would present a significant burden given its limited budget.
