We have established a church in the community of Luzira, Uganda to cause spiritual transformation in this community. The church serves and ministers to 300 adults and 350 children. The youth ministry attracts about 200 young people from the community. The church currently sits on a rental property of an acre in size and meets in a tent that seats about 1,000 people.**4b** (Code:) (Expenses \$ 34,347 including grants of \$) (Revenue \$ 34,347)Social Transformation: Hope House and the Fields City Kindergarten. The kindergarten opened last year with 12 children and currently has 26 children. Through this we are providing education that emphasizes critical thinking rather than the rote education provided by most schools in Uganda. Hope House is a sanctuary and safe place for young girls between the ages of 9 and 13 who have been living in vulnerable circumstances in the community of Luzira. Many of these girls come from families whose fathers have abandoned them and the mothers can hardly make ends meet. The living conditions are so deplorable that the girls are at risk of molestation, defilement, and teenage pregnancy. Hope House is a safe place where they are able to attend school, get a good meal, and learn computer and other life skills. Hope House currently serves 12 girls.**4c** (Code:) (Expenses \$ 5,940 including grants of \$) (Revenue \$ 5,940)Economic Transformation: Fit for Life Program. Through this program, we help young people become entrepreneurs. We provide educational opportunities, mentoring, and financial capital support to help the young people create jobs. The program currently serves close to 50 youth and 3 of these have been direct beneficiaries of educational and capital support. One recently graduated with a certificate in cosmetology and is in the process of establishing a salon. Another graduated with a diploma in mass communication and is currently under internship and mentorship as a news anchor. The third is pursuing a degree in nursing and has established a chicken farm.**4d** Other program services (Describe in Schedule O.)
