

Part III: Overview

Azizi Life exists to participate in the efforts of rural Rwandans to develop themselves, their families, and their communities. At this early stage in our organization, our primary work is in supporting craftspeople such as weavers and woodcarvers. We do this by offering guidance on product design and selection, and purchasing large quantities of these crafts at fair prices. Then a main part of our work in the United States is selling these products so that we can continue to provide new income-generation opportunities to the Rwandan artisans. Our goal is that our craft sales are self-sustaining and profitable, so that we can send profits back to our nonprofit partner in Rwanda. Sustainability will also enable us to send a higher percentage of donations back to Rwanda for charitable community development efforts.

Market Connections

Another portion of our work involves making connections with customers who will then order in bulk directly from Rwanda. This is a newer portion of our work, currently pursued by participation in trade shows where we represent Azizi Life and the artisans. We also make customer connections for a Rwandan community-based tourism project.

Integrated in the work of craft sales and promotion of crafts and tourism is the work of advocacy. We create opportunities to inform Americans about Rwanda and about the lives of our Rwandan partners through our tagging, literature, website, and public speaking. Our goal is to build bridges of understanding, promote fair trade, invite participation in Rwandans' self-development, and inspire Americans with Rwandans' examples of forgiveness, reconciliation, and creative work. As Christians, our goal is also to share Jesus' love to people in both our Rwandan and American communities.

Student Interns

Azizi Life offers internships to students who are interested in learning about the multifaceted work of fair trade craft production, promotion, and sales. Through internships in the US or in Rwanda, we hope to equip students to participate in the fair trade movement so that they will grow as capable global citizens.

Other Charitable Activities in Rwanda

Azizi Life supports other activities in that help rural Rwandans to overcome barriers to their own development. In 2014, Azizi Life donated \$3000 to our Rwandan partner for the purchase of solar lamps and fuel-efficient stoves. Our partner buys the lamps and stoves in bulk and then offers them to our artisan partners on an interest-free payment plan. In this way, the health and wellbeing of families and the environment are improved, and the repayments will be used to make solar lamps and fuel-efficient stoves available to more rural Rwandans.
