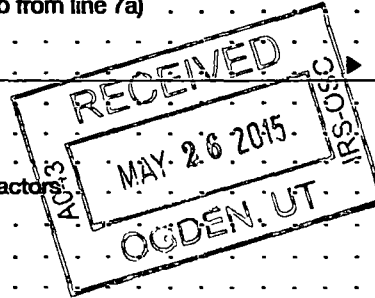

Part I, Line 10 Grants made in 2014 totalled \$102,532. The grants are all made to the Heather Chimhoga Orphan Center in Zimbabwe.

Grants are generally made via wire transfer to the bank account of the organization in Zimbabwe. ZMP has significant influence over how the funds are disbursed in Zimbabwe - but it does not have signing authority over the local Zimbabwean bank account. Thus the grants are not made directly to vendors, schools, workers etc.

Part I, Line 16 The "other" expenses in 2014 were all for a local bicycle event (jerseys, website etc.) - a fund raiser which produced a net of about \$43,000 for organization.

Part I, Line 20 The \$4667 is an amount ZMP had at year end that had been promised to a specific expenditure in Zimbabwe. Thus we accounted for it at year end as a liability as it would be spent for the promised expense in 2015.

Part II, Line 26 Both amounts on this line (\$700 and \$4667) are amounts on hand at year end that have been promised to a particular project and are counted as liabilities in order to keep track of them.
