The Kitchen Community was established in 2011. At June 30, 2014 there were 178 gardens installed. Learning Garden products have been designed and developed to formulate the core of each Learning Garden. Using those products we design the Learning Garden space and manage construction, both site prep and installation for each school site in conjunction with the associated District. We provide an education support program for the gardens including on-site assistance, workshops, newsletter, and online resources to ensure the gardens are being used for teaching and learning. Through surveys and an evaluation process we determine our impact and success of the Learning Gardens and set high-priority school targets.
