 The Mother/Daughter and Father/Son programs empower Middle school Latinos to continue their education through high school and beyond by helping them value the importance of education, develop self-esteem and leadership skills, shatter myths and stereotypes, foster supportive and enduring relationships, and explore future dreams and goals. The program also works
