Other income (line 10) - the medical clinic in Kabul, Afghanistan, generated \$5,614 in revenue in 2014 from office visit charges and pharmacy sales. The medical clinic charges very low office visit fees to discourage/prevent misabuse of its services and to help move the medical clinic closer to financial self-sufficiency. The medical clinic began operating in June 2013, but did not start seeing patients and generating revenue until January 2014, when it obtained its license (required by local regulation).

Overview - Health For Everyone is a 501(c)(3) non-profit organization that is dedicated to providing health care services and education globally, with emphasis on the poor and war-torn people of Afghanistan. The organization manages a medical clinic in Kabul, Afghanistan, and produces educational health care shows that are aired globally via satellite television. All contributions received are used to fund the operations of the medical clinic and help the organization achieve its long term goal of providing greater access to basic health care.

Other expenses (line 16) - these are expenses incurred to set up and operate the medical clinic in Kabul, Afghanistan. These include monthly recurring expenses such as medical supplies, internet, telephone, etc. It also includes one-time costs to prepare the medical clinic for operation, including expenses such as furniture, computers, pharmacy license (required by local regulation), etc.

Other changes in net assets or fund balances (line 20) - this is a plug number to reconcile the beginning assets, net excess for 2014, and the ending assets, and is explained by contributions made by the Ghaussy family to help pay for the operations of the medical clinic in Kabul. These contributions were made directly to the medical clinic, and not to Health For Everyone. For simplicity purposes and due to the fact that Health For Everyone paid for the majority of the medical clinic's expenses in 2014, in this tax return we recognize all revenue and expenses from setting up and operating the medical clinic. The Ghaussy family paid for some of the expenses, and hence, this plug number in line 20.

Land and buildings (line 23) - the medical clinic resides on property that is owned by the Ghaussy family, not Health For Everyone. The construction of the medical building was primarily funded by another non-profit organization (AMZ Foundation) and the Ghaussy family. Health For Everyone donated \$10,000 to help fund the construction of the building. This tax return states Health For Everyone's land and building assets at the historical cost of its contributions to build the facility (\$10,000).

Income from operations (line 2 and line 35b) - the medical clinic generated \$5,614 in revenue in 2014 from office visit charges and pharmacy sales. The medical clinic charges very low office visit fees to discourage/prevent misabuse of its services and to help move the medical clinic closer to financial self-sufficiency. The clinic also offers pharmacy to patients at competitive rates. We consider this revenue as related to the organization's core mission (providing low cost health care services), and hence, do not consider this "unrelated business income."
