A Breath of Hope Lung Foundation receives most of its donations year long from families who have lost loved ones to lung cancer and current patients and their families. A large portion of these donations go to A Breath of Hope Lung Foundation research fellows and their lung cancer research projects at U.S. cancer centers.**4b** (Code:) (Expenses \$ 152,823 including grants of \$ 20,000) (Revenue \$)Lung cancer is anyone's cancer yet the public believes only smokers get lung cancer. A Breath of Hope Lung Foundation hosts 3-5 events per year and intentionally targets different audiences. An expert speaker educates the participants at each event to help them understand the causes, symptoms, available screening and treatments for lung cancer. A Breath of Hope Lung Foundation provided seed money grants to two local cancer centers to help create lung nodule clinics that offer free low dose CT scans to low income community members.**4c** (Code:) (Expenses \$ 19,855 including grants of \$ 10,000) (Revenue \$ 0)Lung cancer patients report that the stigma that accompanies a lung cancer diagnosis adds to the stress and sorrow of the illness. A Breath of Hope Lung Foundation provides hope and patient education through its events, marketing and by supporting local support groups. The A Breath of Hope Ambassador Program uses trained volunteers to provide transportation and companionship to patients who face cancer alone or without the support they need.**4d** Other program services (Describe in Schedule O)
