- (a) to advocate with respect to federal, state and local laws governing siting and permitting of large scale renewable energy projects;
- (b) to advocate with respect to federal, regional, state and local incentive and other financing programs (including Renewable Portfolio Standards and their successors or replacements) to address the needs of large-scale renewable energy power projects;
- (c) to advocate that Independent System Operators (ISOs) (and the various processes that ISOs utilize and their successors) and other relevant federal, regional, state and local departments, agencies, groups and organizations ensure that transmission upgrades serve renewable power interests;
- (d) to gather and disseminate information in order to aid in the creation of mechanisms of transmission of renewable energy and financing in regard thereof;
- (e) to recruit and collaborate with other renewable energy companies, suppliers, utility providers and manufacturers that share a common vision of clean renewable energy, and to contract with lobbyists and technical consultants; and
- (f) to engage in such other activities as may be necessary to carry out the purpose of the Corporation.

- (a) The Corporation shall have perpetual succession in its corporate name.
- (b) The Corporation may sue and be sued.
- (c) The Corporation may have a seal, which it may alter at pleasure.

- (e) The Corporation may sell, convey, lease, exchange, transfer or otherwise dispose of, or mortgage, pledge, encumber or create a security interest in, all or any of its property or any interest therein, wherever situated.
- (f) The Corporation may purchase, take, receive, subscribe for or otherwise acquire, own, hold, vote, employ, sell, lend, lease, exchange, transfer or otherwise dispose of, mortgage, pledge, use and otherwise deal in and with, bonds and other obligations, shares, or other securities or interests issued by others, whether engaged in similar or different business, governmental or other activities.
- (g) The Corporation may make contracts, give guarantees and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage, pledge or encumbrance of, or security interest in, all or any of its property or any interest therein, wherever situated.
- (h) The Corporation may lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (i) The Corporation may do business, carry on its operations, and have offices and exercise the powers granted by Chapter 180 of the Massachusetts General Laws as now in force or as hereafter amended, in any jurisdiction within or without the United States, although the Corporation shall not be operated for the primary purpose of carrying on for profit a trade or business unrelated to its tax exempt purposes.
- (j) The Corporation may pay pensions, establish and carry out pension, profit-sharing, and other retirement, incentive and benefit plans, trusts and provisions for any and all of its employees, including employees who serve as its officers or directors.
- (k) The Corporation may solicit and receive contributions of any amount from any and all sources and may receive and hold in trust or otherwise funds received by gift, devise, grant, bequest or otherwise.
- (l) The Corporation may be an incorporator of other corporations of any type or kind. The Corporation may be a partner in any business enterprise which it would have power to conduct by itself.

(m) The Bylaws may authorize the directors to make, amend or repeal the By-Laws in whole or in part.

(q) An officer or director of the Corporation shall not be personally liable to the Corporation for monetary damages for breach of fiduciary duty as an officer or director not withstanding any provision of law imposing such liability except for liability:

- (i) for any breach of the officer's or director's duty of loyalty to the Corporation,
- (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or
- (iii) for any transaction from which the officer or director derived an improper personal benefit. No amendment to or repeal of this provision shall apply to or have any effect on the liability or alleged liability of any officer or director occurring prior to such amendment or repeal.

(r) Except as may be otherwise required or permitted by law, the Corporation may at any time authorize a petition for its dissolution to be filed with the Supreme Judicial Court of the Commonwealth of Massachusetts pursuant to Section 11A of Chapter 180 of the Massachusetts General Laws by the affirmative vote of a majority of the directors of the Corporation then in office; provided, however, that in the event of any liquidation, dissolution, termination, or winding up of the Corporation (whether voluntary, involuntary or by operation of law), the property or assets of the Corporation remaining after providing for the payment of its debts and obligations shall be conveyed, transferred, distributed, and set over outright to one or more organizations organized for nonprofit purposes similar to those of the Corporation and exempt under either Section 501(c)(3) or 501(c)(6) of the Code, as a majority of the total number of the directors of the Corporation may by vote designate and in such proportions and in such manner as may be determined in such vote.

(s) No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to, any officer or director of the Corporation or any private individual for any purpose other than those purposes as set forth herein, except that the Corporation may pay reasonable compensation for services rendered and make payments and distributions in furtherance of its exempt purposes. The Corporation intends to be entitled to exemption from Federal income tax under Section 501(c)(6) of the Internal Revenue Code.

(t) The Corporation may purchase, receive, take by grant, gift, devise, bequest or otherwise, lease or otherwise acquire, own, hold, improve, employ, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.

(u) The Corporation shall have and may exercise all powers necessary or convenient to effect any or all of the purposes for which the Corporation is formed; provided, however, that no such power shall be exercised in a manner inconsistent with Massachusetts General Laws, Chapter 180 or any other chapter of the General Laws of The Commonwealth of Massachusetts; and provided, further, that the Corporation shall not engage in any activity or exercise any power not permitted to be engaged in or exercised by a corporation exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Code.

(v) All references herein: (i) to the Internal Revenue Code shall be deemed to refer to the Internal Revenue Code of 1986, as now in force or hereafter amended; (ii) to the General Laws of The Commonwealth of Massachusetts, or any chapter thereof, shall be deemed to refer to said General Laws or chapter as now in force or hereafter amended; and (iii) to particular sections of the Internal Revenue Code or the General Laws of The Commonwealth of Massachusetts shall be deemed to refer to similar or successor provisions hereafter adopted.

**ARTICLE V**

The effective date of the Restated Articles of Organization of the corporation shall be the date approved and filed by the Secretary of the Commonwealth. If a later effective date is desired, specify such date which shall not be more than thirty days after the date of filing.

**ARTICLE VI**

The information contained in Article VI is not a permanent part of the Articles of Organization.

Attached for submission please find the Restated Articles of Organization of Renewable Energy New England, Inc., a Massachusetts ch. 180 organization (the "Corporation"). As you will see, Article I has been restated to change the Corporation's name to "RENEW Northeast, Inc." We understand that the name "RENEW Northeast, Inc." could not be reserved as the Corporations Division has identified "RENEW, LLC" (the "LLC") as an entity existing in the Commonwealth with a similar name.

While we recognize that the names of the Corporation and the LLC both begin with "RENEW" and understand that the Division disregards geographical references (e.g., "Northeast") in determining name availability, we respectfully disagree with the Division's initial determination that the Corporation should obtain a consent to use of name from RENEW, LLC and request use of the name without this consent.

We understand that one of the Commonwealth's primary concerns in examining applications for registration is the potential for confusion in the public marketplace. To our knowledge, the LLC does not have a public profile including a website or other internet presence that might result in confusion with the Corporation. Based on the 2013 Annual Report of the LLC, as filed with the Commonwealth, it appears that the LLC had intentions to engage in the business of real estate. We have not, however, found any evidence that the LLC has actually engaged in real estate activities (or any other activities) in the public marketplace.

In comparison, the Corporation was formed to support and advance the development of clean and sustainable renewable energy resources within the New England states (and has now expanded throughout the Northeast region). Based on this distinctively different



purpose, the Corporation believes that the risk for confusion in the marketplace, between the Corporation and the LLC, is very low. As evidence of this belief, the Corporation is already commonly referred to as "RENEW" in the marketplace and the Corporation is not concerned its business will be harmed if the LLC were to create a public profile and become very active at some point in the future.

Furthermore, the organizational structures of the Corporation and the LLC are each unique and different. The Corporation has been organized as a ch. 180 organization in the Commonwealth and currently operates as a tax-exempt organization under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended. The LLC, in comparison, has been formed as a limited liability company and appears to operate as a for-profit organization based on its 2013 Annual Report.

Based on the fact that there will be close to zero opportunity for confusion in the public marketplace and the unique organizational differences, we respectfully request that the Division approve the Corporation's Restated Articles of Organization without a consent to use of name from the LLC. Please do not hesitate to contact me if you have any other questions about our request and thank you for your consideration.


