GROUPS MEET ONCE A WEEK FOCUSING ON ADVOCACY CAMPAIGN PROJECTS, ASSET DEVELOPMENT, CASE MANAGEMENT, COLLEGE EXPOSURE, COMMUNITY SERVICE, CULTURAL ENRICHMENT ACTIVITIES, EDUCATIONAL ENRICHMENT, EMPLOYMENT, ENTREPRENEURSHIP, FIELD TRIPS, FINANCIAL LITERACY, GOAL SETTING, LEADERSHIP TRAINING, LIFE SKILL WORKSHOPS, PEER PRESSURE. EACH COMPONENT IS PRESENTED TO EACH AGE GROUP IN A MANNER IN WHICH IT CORRELATES TO THEIR LEVEL OF UNDERSTANDING. OVER TIME, EACH YOUTH IS EXPECTED TO DEMONSTRATE AN INCREASED UNDERSTANDING AND HAVE THE ABILITY TO APPLY WHAT THEY HAVE LEARNED TO VARIOUS STAGES OF THEIR DEVELOPMENT. IN 2014, 150 YOUTHS WERE ENROLLED AND PARTICIPATED IN ONE OR MORE GROUP ACTIVITY, AND 35 COMPLETED ALL EIGHT ENRICHMENT COMPONENTS AND GAINED THE BENEFIT OF IMPROVED SOCIAL/EMOTIONAL DEVELOPMENT AND/OR IMPROVED SCHOOL SUCCESS. ADDITIONALLY, THE YOUTH EMPOWERMENT CENTER FOR THE FIRST TIME IN SEVERAL YEARS HOSTED 250 CAMPERS, DURING THE SUMMER FOR A SERIES OF WEEKLY CAMPS. CAMPERS COULD SELECT TO ATTEND UP TO THREE CAMPS THAT FOCUSED ON ART, MUSIC, THEATRE, SPORTS, SCIENCE, COOKING AND GARDENING. THE CAMPS WERE A SUCCESS, DUE TO THE EFFORTS OF ALL THOSE INVOLVED AND ADDRESSED A COMMUNITY NEED, A LACK OF SUPERVISED SUMMER ACTIVITIES FOR LOW-INCOME YOUTHS. IN 2014, COMMUNITY ACTION PARTNERSHIP COMPLETED ITS FIRST YEAR OF IMPLEMENTATION OF THE FLIGHT (FUTURE LEADERS IN GEAR OF HIGHER TRAINING) PROGRAM. THE PROGRAM WAS FUNDED BY MONTGOMERY COUNTY'S WORKFORCE INVESTMENT ACT FUNDING, THROUGH THE MONTGOMERY COUNTY DEPARTMENT OF JOBS AND FAMILY SERVICES. IT PROVIDED ASSISTANCE TO ELIGIBLE MONTGOMERY COUNTY IN-SCHOOL AND OUT-OF-SCHOOL YOUTH AGES 16-21, TO COMPLETE HIGH SCHOOL OR TO OBTAIN EMPLOYMENT AND TRAINING SERVICES. THE PROGRAM PROVIDED FOR BASIS EDUCATION SKILLS, GENERAL EQUIVALENCY DIPLOMA PREPARATION, REMEDIAL READING, WRITING, MATHEMATICS, LITERACY TRAINING, AND/OR STUDY SKILLS. ACTIVITIES INCLUDED JOB SEARCH ASSISTANCE, TUTORING, LEADERSHIP SKILLS, JOB REFERRAL, WORK EXPERIENCE, JOB PLACEMENT, CASE MANAGEMENT, FOLLOW-UP SERVICES, BASIC SKILLS AND OCCUPATIONAL TRAINING. SUCCESSFUL OUTCOMES INCLUDED 48 YOUTHS THAT OBTAINED LITERACY GAINS OR FOUND EMPLOYMENT. THE SAVE THE DREAM OHIO PROGRAM PROVIDED TARGETED HOMEOWNERS WHO WERE STRUGGLING TO MEET THE FINANCIAL OBLIGATION OF THEIR MORTGAGE PAYMENTS. THE PROGRAM WAS OPERATED IN PARTNERSHIP WITH OHIO HOUSING FINANCE AGENCY AND THE U.S. TREASURY. HOMEOWNERS IN FINANCIAL DIFFICULTY WHO WISHED TO RETAIN THEIR PROPERTIES COULD RECEIVE THE BENEFIT OF THE PROGRAM. ADDITIONALLY, THE PROGRAM ASSISTED HOMEOWNERS WITH A GRACEFUL AND DIGNIFIED EXIT FROM THE PROPERTY IF THEY ARE NO LONGER WISHED TO RETAIN OWNERSHIP. COUNSELING WAS PROVIDED ON AN AS-NEEDED BASIS AT TIMES THAT WERE SATISFACTORY TO THE CUSTOMERS AND COUNSELORS. PARTICIPANTS WOULD CONTACT THE AGENCY'S HOUSING DEPARTMENT FOR ASSISTANCE. THEY WOULD SCHEDULE A FACE-TO-FACE APPOINTMENT WITH A HOUSING COUNSELOR, IN WHICH THE COUNSELOR WOULD ASSESS THE HOMEOWNERS' FINANCIAL SITUATION, HARDSHIP AND LOAN DOCUMENTS. COUNSELORS WOULD ADVISE THE HOMEOWNER ON POSSIBLE HOME RETENTION OPTIONS AND CREATE A BUDGET AND AN ACTION PLAN, AS WELL AS COMPLETING NECESSARY IN-HOUSE FORMS AND COLLECTING DOCUMENTATION FROM THE HOMEOWNER TO SUPPORT THE HARDSHIP AND FINANCIAL SITUATION. THE COUNSELOR WOULD ASSIST THE HOMEOWNER IN PREPARING AND SUBMITTING LOAN MODIFICATION PACKAGES FOR LENDER REVIEW. IF RETENTION OF THE PROPERTY WAS NOT A VIABLE OPTION, THE COUNSELOR WILL DISCUSS ALTERNATIVES. THE COUNSELOR IF SOME INSTANCES REFER THE HOMEOWNERS FOR LEGAL ASSISTANCE, OR TO OTHER AGENCIES FOR ADDITIONAL ASSISTANCE AS NEEDED. IN 2014, 65 HOUSEHOLDS WENT THROUGH THE PROGRAM AND RECEIVED ASSISTANCE IN MAINTAINING THEIR HOMES.
