Preserve WV AmeriCorps program is a statewide service initiative to promote community development through historic preservation. In 2014, PAWV deployed 19 AmeriCorps members throughout West Virginia. Member's activities focused on economic development related to historic resources, heritage tourism, and capacity building for historical organizations with a major focus on volunteer engagement for those organizations. In 2014, member projects included but were not limited to completing nominations to the National Register of Historic Places, developing and implementing heritage tourism events, organizing projects to clean up historic properties, and planning and promoting the re-use of historic places.

PAWV's Field Services Program is a statewide program in which Preservation Alliance staff travel to historic sites to provide technical assistance to preserve the built environment. This includes the Endangered Properties Program, where historic properties with public support, but in danger of being lost, are designated to the program by PAWV. Sites designated receive advocacy and assistance from PAWV staff for the re-use and preservation of these properties. Additional services provided within the Field Services program include educational workshop services, prioritized narrative needs assessments, and services adapted to the needs of each site.

PAWV's biennial historic preservation conference was held on September 25-27 in Huntington, WV. Each conference is held at a different location every other year. The historic preservation conference offers educational programming through hands-on workshops, educational field trips to view historic preservation projects, concurrent educational sessions, guest speakers, and more. The conference is open to the public, with reduced admission rate available for students and community volunteers. The annual historic preservation awards banquet was held during the conference.
