	CareSource, a leading nonprofit managed care organization based in Dayton, Ohio, has been living its mission to make a lasting difference in our members' lives by improving their health and well-being for more than 25 years. CareSource serves more than 1.2 million Medicaid members in Ohio alone. CareSource's spectrum of services include: (1) Medicaid consumers, including families with low income, children, pregnant women, those who are aged, blind or disabled, and those who are eligible for Home and Community Based services through execution of an annual Provider Agreement with the Ohio Department of Medicaid (ODM); (2) Dually eligible consumers for Medicaid and Medicare through Ohio's Integrated Care Delivery System, MyCare Ohio, and (3) Qualified Health Plans, called CareSource Just4Me, offered through the Federal Health Insurance Marketplace, providing low-cost comprehensive coverage for individuals and families. CareSource pioneered Ohio's first mandatory Medicaid managed care program in 1989, and is now one of the largest Medicaid managed care plans in the country. CareSource's Ohio Medicaid programs serve Covered Families and Children (CFC), including Healthy Start and Healthy Families, members of the Aged, Blind or Disabled (ABD) population, and consumers eligible for the Home and Community Based Services (HCBS) waiver program. CareSource's years of experience in managing Medicaid managed care programs and member focused approach to care have allowed CareSource the opportunity to forge strong, positive regulatory relationships with state agencies, including departments of insurance. In Ohio, CareSource has earned nearly 53% of the statewide managed care market share and has the highest voluntary enrollment rate and the lowest voluntary disenrollment rate of all participating Medicaid Managed care plans. CareSource targets a medical spend of 92% with a target administrative rate of 6.0%. At the core of its mission, CareSource focuses on prevention with a goal of improving member health, the quality of health care services received and accessibility of health care services for Medicaid members via an innovative health and wellness methodology. CareSource has a broad, statewide network of more than 25,000 providers, including primary care and specialist physicians, hospitals, nursing facilities, home health care agencies and other medical providers who provide medical services as well as assist in the coordination of member care. Additionally, CareSource offers 24-hour nurse call center coverage staffed by Registered Nurses to provide around-the-clock medical advice to access appropriate care and divert unnecessary emergency department visits. CareSource's commitment to quality is demonstrated through the Organization's National Committee for Quality Assurance (NCQA) and URAC accreditations. CareSource is Accredited for the Medicaid HMO Health plan by NCQA. NCQA is a private, nonprofit organization dedicated to transforming health care quality through measurement, transparency and accountability. NCQA consistently raises the bar on health care plan performance by continually increasing quality improvement standards. Ohio, like other states, has put an increased focus on accreditation to ensure all Medicaid plans are ranked on a standard of quality and health outcomes. CareSource maintained its URAC Full accreditation for compliance with health utilization management and health call center. Accreditation by both NCQA and URAC demonstrate CareSource's commitment to quality and enhances CareSource's ability to improve the health and well-being of those we serve. CareSource's community-based care coordination program serves members who have the greatest need for case management services. Members receive enhanced care management services based on their complex physical, behavioral and social health needs. CareSource's community-based team of nurses, social workers and Community Health Workers, and Navigators, works in the community to guide members through the complex and often-confusing medical and social service systems. CareSource collaborates with community partners and providers such as the Area Agencies on Aging, Community Mental Health Centers, local Pharmacies, and Federally Qualified Health Centers to ensure members receive the services they need. CareSource's face-to-face model offers a holistic view of our members' needs, reinforcing the direct link between the member, provider and health plan. In 2014, CareSource launched its MyCare Ohio product, as part of Ohio's Integrated Care Delivery System. CareSource entered into a three-way contract with Ohio Medicaid and the Centers for Medicare and Medicaid Services (CMS) and began serving these new members in May 2014. By connecting Medicaid and Medicare, CareSource is helping Ohioans achieve better health outcomes, thereby reducing unnecessary or redundant costs from fragmented health systems. Through MyCare, CareSource members receive person-centered care management that coordinates their physical, behavioral, long-term care, and social needs. Through a contract with ODM, CareSource manages consumers in the Columbus, Cleveland and Marietta regions of Ohio (67 counties) who are eligible for the Home and Community Based Services (HCBS) waiver, also known as the Ohio Home Care Waiver. Through this program, CareSource provides in-home and community-based care management services that help individuals remain at home instead of residing in a nursing home or other long-term care facility. CareSource serves more than 2,000 individuals in the Medicaid waiver program. CareSource Just4Me, an important part of the Organization's mission to serve the underserved, offers affordable coverage to those who need it most through low premiums, copayments and deductibles. In Ohio, Just4Me was successfully implemented with an effective date of coverage of January 1, 2014. The CareSource Family of Companies. Insurers currently have three Qualified Health Plans operating in both Federally Facilitated (FFM) and State Based marketplaces. Ohio and Indiana are FFM states while Kentucky is a SBM. Each year, CareSource submits the Qualified Health Plan Application as outlined by CMS. Certification of our plans are received by mid-September qualifying CareSource to offer health plans in the Health Insurance Marketplace and Kentucky Health Benefit Exchange. In 2014, CareSource launched its innovative and ground-breaking Job Connect program, part of its larger Life Services initiative. The Life Services initiative aims to make a sustained impact in members' lives by effectively addressing the obstacles that impede progress in a member's journey toward self-sufficiency, improved health, and well-being. CareSource's Job Connect program recognizes the barriers an individual may have in preparing, securing, and performing at a sustainable level necessary to secure long-term employment. CareSource has extended the expertise of CareSource University (CSU), our nationally recognized training program, by offering a job preparation course to our members that includes life and workplace skills. CareSource's Job Connect program incorporates training and preparing candidates for interviews by addressing topics such as computer literacy, appearance and dress for success, office etiquette and professional relationships, resume writing, and interviewing skills. Once a candidate successfully secures employment, CareSource continues the journey, supporting them with ongoing coaching to ensure success during the initial stages of employment. CareSource's innovative programs aim to improve health outcomes, while remaining member focused and treating the whole person. CareSource addresses not only a member's medical issues, but also a member's psychosocial issues that can create barriers to receiving quality health care. CareSource has partnered with Outcomes MTM to deliver a Medication Therapy Management (MTM) program. The program provides focused MTM services, including face-to-face member visits with pharmacy staff. Pharmacists provide complete medication reviews to help members with their medications. By providing this service, the organization has decreased unnecessary hospitalizations and emergency department visits. CareSource is one of only a few Medicaid plans, and the largest nationally, to voluntarily provide this service to its Members. CareSource provides enhanced benefits to members that are above and beyond required benefits defined by state or federal agencies. In order to ensure members are able to access the most appropriate medical care, CareSource provides transportation services for office visits to their medical provider's office, ensuring that members are keeping preventive, sick or follow-up appointments. Further, ensuring that our most vulnerable members receive needed care, CareSource does not charge Medicaid members a copayment for pharmacy products, dental visits, vision examinations, vision hardware.
