BLOCK GRANT Program Service Accomplishments: The goal of the USA Diving block grant was to aid the general operating budget. The funds were used to cover expenses for national championship events for junior and senior divers and for member benefits such as insurance. Activity objective for this time period and the long-term goal: The long-term goal of the block grant is for USA Diving to continue to be able to provide services and benefits to the membership. Events and insurance are the fundamental reasons USA Diving exists and this grant helped facilitate these items. USA Diving currently has around 8,000 members so these funds will go to serve the current membership as well as improve the outlook for future members.

INTERNATIONAL GRAND PRIX COMPETITIONS Program Service Accomplishments: This grant allows USA Diving to send athletes to various international competitions to compete against the world's best athletes as well as gain international experience which is crucial prior to the World Championships and Olympic Games. Athletes competed in 48 different events and three different international competitions. The long term goal is to expose USA Diving athletes to as much international competition and as many international judges as possible. The exposure helps the athletes excel in both the World Championships and Olympic Games.

USA DIVING INDIVIDUAL 2014 FINA WORLD JR CHAMPIONSHIPS AND OPENING THE MINDS TOUR TO CHINA FOR JR COACHES Program Service Accomplishments: These programs both center around the junior diving program. The FINA World Junior Championships are an opportunity for our best junior athletes to win medals, gain international experience and to make a name for themselves as divers in the international world. This U.S. Junior National Team included 24 athletes. The Opening of the Minds Tour involved 14 Junior coaches and six support staff to China to expose USA Diving Junior coaches to the world's best training techniques so the junior divers can benefit from this knowledge and training. The long term goal is to build our athlete pipeline. Providing our junior athletes with international competition experience is necessary for these athletes to become our next generation of athletes. On the coaching front, our top junior athletes are able to expand their knowledge which will benefit not only the current athletes they are coaching but future athletes as well.
