The policy requires independent board members to determine the bounds of comparable compensation within comparable organizations of similar size and geographical area or areas similar to it. Several documents including the United Way of Central Ohio Salary & Benefits Report are used to establish comparable data. The board documents the basis for its determination in the minutes of the board meeting called for the purpose of setting executive compensation.
