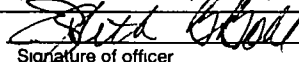

Simon Kenton Pathfinders primary purpose is to build and maintain a multi-use trail and to provide trailside amenities for the multi-use trail which links Champaign and Logan Counties, OH to the Ohio & Erie Trail as well as to the Little Miami Trail

Part III 28a & 28b Statement 2

Through the support of the Champaign and Logan County communities and surrounding areas in the form of donations and volunteer help, regular trail maintenance occurs including mowing, clearing and making minor repairs. The maintenance efforts of the Simon Kenton Pathfinders assists both the Champaign and Logan County and City of Urbana and Bellefontaine governments as well as the Village of West Liberty government. Fundraising efforts over the past years raised monies to provide sealcoating of 1/2 of the existing paved trail from Clark County line north to Urbana. Monies are continuing to be raised for long term maintenance which will include additional sealcoating and eventual replacement of the approximate 10 miles of the original paved trail that directly links over 50% of the City of Urbana. An estimated 160,000 people use the trail annually providing a safe travel alternative and an added healthy lifestyle benefit. It is now possible to travel by trail from Urbana to Cincinnati, OH on a paved trail. In past years, a variety of fundraising events were conducted in order to raise monies to assist the City of Urbana with the purchase and renovation of a former railroad depot to provide trailside restrooms, rest areas and parking for the public. The funds continue to be raised to assist both Champaign County and City of Urbana with maintenance of the established trail. An estimated 160,000 people use the original paved trail annually.

The fundraising events that were conducted also raised monies to continue assisting the City of Urbana with the maintenance of a former railroad depot to provide restrooms, rest areas, bike lockers and parking for the public. Volunteers continued fundraising for an extension of the multi-use trail northward through West Liberty to Bellefontaine which was completed late fall, adding an additional 18 miles. This is a crushed stone trail. This provides access to two communities in Logan County, OH, their businesses, schools and points of interest. The Simon Kenton Pathfinders assisted the governments of West Liberty and Bellefontaine with the creation of public access and

parking areas for the additional trail After the extended trail is officially open this spring, it will be possible to travel from Bellefontaine to Cincinnati, OH by trail. There is a projected increase in usage of an additional 30,000 people.
