Quechua Benefit solicits public support from alpaca farmers and other alpaca industry participants as well as the general public to fund a variety of social service programs operating in the highland regions of Peru, home to the native Quechua peoples. Most US alpaca herds and herd sires claim their heritage from this region of Peru. Quechua Benefit creates a medium through which members of the alpaca industry can make donations to enhance the lives of the Quechua people of Peru. Quechua Benefit provided direct financial support to a number of food programs, orphanages and disaster relief programs operating in the highland region and provides indirect support through Quechua Benefit Peru, its companion organization established as a Peruvian nonprofit. It organizes annual medical missions to the region by assembling volunteer medical personnel from many medical disciplines. The teams travel around the region and provide medical care from mobile clinics. Several times during each year the organization operates traveling dental, optometry and medical clinics in the region. The organization has completed construction of the Casa Chapi orphanage in the Colca Valley of Peru which provides housing, education, and medical services to orphaned children in the Quechua region. Plans to expand the orphanage are under way.
