PART IX-A Summary of Direct Charitable Activities

1. ***Foundation's Charitable Activities.*** The Allen Foundation (the "Foundation") was formed on April 25, 2000, for the purpose of providing humanitarian and development aid to individuals in the most desperate areas of the world. To accomplish its charitable purposes, the Foundation began work in Cambodia, a country that has suffered almost unimaginable devastation and poverty for over three decades. Its projects in Cambodia were initiated under the supervision of Jacquelin Cochran, a project manager with graduate training through the Energy & Resources Department at the University of California at Berkeley where she specialized in the use of water purification and renewable energy technologies in South-East Asia.

2. ***Joint Venture with Stung Treng Women's Development Center (SWDC).*** As a continuation of its efforts in providing humanitarian and development aid in Cambodia, a joint venture in Cambodia's Stung Treng province was undertaken with Stung Treng Women's Development Center (SWDC) to reduce poverty by developing village-based sericulture which will enable local farmers to raise silkworms on mulberry trees, harvest and refine silk locally. The project focuses on developing life skills that assist in breaking the cycle of poverty and illiteracy for vulnerable people, especially women in the region. The programs offer opportunities that improve living standards through education, vocational training and employment.

Between 2002 and 2014 SWDC has directly supported over 574 women, 981 children, 150 men, and directly assisted 675 families in the impoverished Stung Treng region of Cambodia. The SWDC programs now include:

- Education Program in Literacy and Health
- Education Program School Sponsorship
- Vocational Training in Traditional Weaving and Sewing
- Vocational Training in Carpentry and Building
- Vocational Training in Sericulture
- Vocational Training in Retail Management, Accountancy, Design and Product Development, and Computer Skills
- Provide Child Care Program for workers, including kindergarten and pre-school
- Employment at SWDC production center for Mekong Blue
- Employment at SWDC café and gallery
- Employment at SWDC Sericulture program
- Free Lunch Program for workers – this was discontinued in November, 2013
- Child Development Center opened January, 2013
- On-Site Medical Health Clinic to Provide Health Care for Staff and Children

In August 2013 the Foundation entered into a new joint agreement with SWDC funded with \$25,000. The purpose of the December, 2013 agreement was for the construction of a new Kindergarten facility for the purpose of providing early childhood education to rural Cambodian communities. In August of 2014 the Foundation and SWDC amended their joint agreement SWDC to instead renovate the existing Kindergarten facility by extending the building by adding one more large class room, building a double toilets and a hand washing facility for children, and enlarging the playground area for children. SWDC understands that good health and effective education go hand in hand with significant improvements in general development. The renovated Kindergarten will enable more children to make a better start in their educational life and engender a culture of learning among younger Cambodians. This will help break the cycle of poverty in this province.
