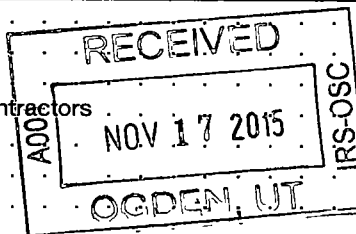

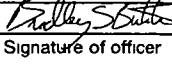

BRAD SPOKE AT THE ACTION SPORTS AREA OF ROCK OF AGES FESTIVAL IN NAPA VALLEY, CALIFORNIA IN OCTOBER 2014. THERE WERE 8000 IN ATTENDANCE AT THE FESTIVAL AND HUNDREDS IN THE SPORTS ZONE WITH A NUMBER OF DECISIONS FOR CHRIST RECORDED. BRAD ALSO TRAINED AROUND 50 COUNSELORS.

P4PI WASHED AND CLOTHED THE FEET OF AT LEAST 1000 CHILDREN IN THE SLUMS.

P4PI ORGANIZED AND INITIATED THE SHIPMENT OF OVER 12,000 SANDALS AND FLIP-FLOPS FOR WOMEN. THEY WERE NOT ACTUALLY SHIPPED UNTIL THE FIRST COUPLE OF DAYS IN JANUARY 2015, BUT THE LOADING, PLANNING, FUNDRAISING WAS DONE IN 2014. IN ADDITION TO THE SANDALS, A MOTOCROSS BIKE FOR OUTREACHES, CLOTHES SCHOOL EQUIPMENT & LIBRARY BOOKS FOR A BIBLE COLLEGE WERE ALSO SECURED FOR SENDING TO INDIA.

PROFESSIONAL DEVELOPMENT:

BRAD ALSO STARTED HIS DOCTORAL PROGRAM AT MULTNOMAH UNIVERSITY TO GROW IN UNDERSTANDING HOW TO HELP EVANGELISTS ONCE AGAIN WORK WITH LOCAL CHURCHES TO SEE DISCIPLES MADE ACROSS THE GLOBE IN A GREATER WAY. BRAD FINISHED HIS FIRST YEAR OF CLASSES IN A 4-YEAR PROGRAM.
