FILMMAKER FEES: The Film Collaborative (TFC) expanded its core activity of festival distribution and educational services for non-commercial cinema, handling up to 15 films at any given time that address social justice, environmental and LGBT issues. TFC continues to be a critical resource for filmmakers of such films and for audiences eager to see them via public educational or festival exhibition. Often these films cannot be seen on TV later.

4b (Code) (Expenses \$ 93,693 including grants of \$ 53,947) (Revenue \$ 0)

FISCAL SPONSORSHIP: TFC grew its Fiscal Sponsorship program offering the lowest commission structure available to filmmakers so they can create culturally important/educational cinema sustainably.

EDUCATIONAL: TFC published its sequel to its case study book 'Selling Your Film Without Selling Your Soul'. TFC continues to maintain its extremely educational blog 'resourceplace', digital distribution, and conducts one-on-one educational consultations with filmmakers. TFC's unique blog and educational content is read by thousands of filmmakers. TFC is also educating filmmakers by both partly inspiring, and participating in Sundance Institute's 'Transparency Project', at Sundance's ArtistServices workshop.
