Physical Education Program (PEP) In 2011, America On Track received another 3-year Carol M White Physical Education Program grant to implement the On Track Through Fitness project, a comprehensive physical activity, health, and nutrition program to directly serve K-12 students to help them meet State Standards On Track Through Fitness was designed by incorporating multiple evidence-based model programs to serve disadvantaged Hispanic youth living in the most impoverished neighborhoods in Santa Ana, California America On Track, with eight collaborative community partners, addresses critical gaps as well as enhances health and fitness services at nine schools (four OCDE/ACCESS high schools and five private Catholic K - 8 schools) The overall goal is to improve the children's physical education by providing instruction in physical fitness activities, healthy eating habits, and good nutrition, with an ultimate goal of creating lifelong healthier habits EVALUATION RESULTS AOT staff continued to provide weekly physical education and nutrition education sessions for over 1,700 students at 9 school sites After researching the latest state-of-the-art multisensory brain-body fitness training systems, AOT donated a \$30,000 system (from allocated PEP funds) to Christ Cathedral Academy SMART (Sensory, Motor, Activity, Reaction, Training) technology integrates brain fitness with body fitness -- it improves speed, reactions, and concentration in a fun, challenging, full-body workout experience for all ages and abilities AOT coordinated training sessions to help the school staff learn how to use the new equipment In partnership with Northgate Markets, AOT supported their Viva La Salud project by donating two brand-new produce coolers for two of their Santa Ana stores The new produce coolers are prominently featured at the front of the produce section near the entrance of the store and they include a sign that promotes America On Track and a healthy living message Finally, AOT partnered with the City of Santa Ana to help build their 4th Exercise Park at Memorial Park Through funds from our physical education program grant specifically allocated for fitness equipment, America On Track donated \$45,000 to the City of Santa Ana and worked with them to identify the fabulous Greenfields exercise equipment that was installed AOT has seen outstanding results with the PEP project 47% increase in the % of students meeting cardiovascular fitness targets and 48% increase in the % of students reporting consuming the recommended minimum of two fruits and three vegetables daily (among other great results)

America On Track continued to implement a Tobacco Prevention Project (an innovative, comprehensive, community-based program that is being implemented throughout Orange County - funded by the Orange County Health Care Agency) in the cities of Orange, Newport Beach, Rancho Santa Margarita, San Juan Capistrano, and Mission Viejo The goal of the project is to lower youth access to tobacco This is done by working with local tobacco retailers (274 in the 5 targeted cities) to educate them on the state laws that prohibit selling tobacco to minors EVALUATION RESULTS AOT staff conducted over 800 merchant education training sessions with the commercial tobacco retailers, which led to the following results i) Lowered the number of retailers willing to sell tobacco to minors to zero, ii) Helped 235 out of 274 (86 4%) commercial tobacco retailers become compliant with window signage laws, iii) Helped 207 out of 274 (75%) commercial tobacco retailers reach the 5 Star Merchant status, iv) Raised by 179% the number of people who knew the \$200 fine for providing tobacco to a minor from year 1 to year 3 Additionally, AOT staff conducted over 100 presentations to businesses, civic groups, and parent organizations and collected 2,147 pre and post surveys

America On Track is implementing a 5-year grant (2010-2015) from the California Tobacco Control Project to reduce secondhand smoke exposure in Santa Ana, Orange, Tustin, and Costa Mesa for our Smoke-Free Outdoor Dining and Smoke-Free Child Care Objectives, and throughout Orange County for our Smoke-Free Multi-Unit Housing Objective EVALUATION RESULTS Efforts under this grant during FY2014 have yielded the following results 11 Multi-Unit Housing complexes and 1 Condominium Association adopted a 100% smoke-free policy including individual units and balconies, representing a total of 720 residential units, 35 licensed residential child care facilities adopted 100% smoke-free policies for their properties, and 13 restaurants adopted smoke-free outdoor dining policies

America On Track's Emerging Leaders program is a unique, multi-faceted afterschool program designed to inspire today's youth to become tomorrow's leaders through a focus on the development of strong leadership and public speaking skills in order to help create a brighter future. It is a huge time commitment because it pairs outstanding teens with 4th through 6th grade students in a very structured afterschool program that requires weekly attendance from 2:30 pm to 6:30 pm throughout the entire school year (30 sessions). America On Track staff members lead the program that provides the following components: Leadership Training, effective Public Speaking Skills Coaching, Training on How to Become a Successful Mentor, Social & Character Development, Nutrition Education, Music Appreciation as well as Fitness & Recreation, and much more. The teen leaders participate in the leadership process provided by America On Track, and their many talents and skills are incorporated into various components of the program. The teens receive intensive and ongoing training and are coached to assist in presenting lessons. It is a synergistic approach to developing future leaders. Our Emerging Leaders program is designed to benefit the teens and the elementary school students as well as our communities. **EVALUATION RESULTS:** During FY2014, AOT staff recruited, trained, and worked with 305 mentors and mentees at the Irvine and Santa Ana Emerging Leaders sites. Additionally, 50+ leadership and training sessions were held at those sites. AOT also revised the Emerging Leaders curriculum to further motivate the teen leaders and the program. AOT hosted two ELP Teen Leaders as interns during the summer. Also, AOT recruited and trained 6 new college interns to help out at the ELP sessions. An all-day training session was held for the teen leaders and their parents (parents stay for first 3 hours). AOT staff also interviewed, selected, and trained 6 new teen Site Leaders for the Irvine and Santa Ana sites.

America On Track's Brighter Futures for Children of Prisoners program is a holistic and multi-faceted comprehensive approach to helping the most vulnerable children of Orange County. For almost 12 years now, the successes of our Brighter Futures program for children of prisoners has been based on 3 interwoven components: a one-on-one mentoring program with trained and carefully selected adults who meet with their mentees every week for 2 hours per week, STEM workshops on a quarterly basis to promote a useful and fun approach to science, a "College Is For Me Too" summer educational/inspirational camp at a college campus to demonstrate that college is attainable and enjoyable. Additionally, AOT provides free age-appropriate books, special outings, nutritional seminars and wraparound services to the guardians and children. Since the cost of incarceration is now 69 billion dollars per year nationwide and Orange County is #7 in the Nation in prison population, and 1 of every 5 CA discretionary dollars goes to incarceration, this is a problem of great magnitude. The children of incarcerated parents (over 20,000 in OC alone) who did not choose these parents are predicted to follow in their footsteps if they do not receive support and guidance. AOT is the only nonprofit in OC providing comprehensive services to these "forgotten" children. **EVALUATION RESULTS:** During FY2014, AOT served 502 unduplicated individuals (including 83 children of prisoners, 336 family members, and 83 mentors). AOT staff continued to support existing mentor-mentees matches while also initiating new matches. Additionally, AOT staff provided wrap-around services to the 336 family members of the children of prisoners. AOT launched its STEM program and had 2 successful STEM workshops. The 8th annual College Is For Me Too! Summer Education Camp took place at CSUF at the end of June and was a big success. In addition to the STEM workshops and the College Is For Me Too! Summer Camp, AOT staff members coordinated 8 special events at the Honda Center with mentors and mentees. AOT distributed hundreds of age-appropriate books to promote reading and interest in education. Also, 37 Thanksgiving food baskets were distributed to mentee families.
