Provided 12 water projects within the Trichy District of Tamil Nadu through our indigenous partner, Depressed People's Welfare Association. The impact of the water projects is estimated to be around 6,000 rural men, women and children. Additionally, provided financial assistance to Annai Erica Public School and Orphanage for books, material, food, teacher salaries and other miscellaneous expenses benefiting 1,000 students. Invested in 3 different communities as part of a holistic outreach program seeking to bring uplift to the community through after school tutoring program and other community development programs which will benefit around 500 people.

Provided 13 water projects within the Dang District of Gujarat through our indigenous partner, Ashirwad Sews Kendra Trust. The impact of the water projects is estimated to be around 1,500 rural men, women and children in this mountainous tribal region. Provided partial funding for a mobile medical unit which will travel to various villages providing basic medical care in areas where no medical facilities currently exist. The impact of the mobile medical unit is tremendous in that at each village basic medical care will be available for the first time. Provided financial assistance for Lydia's Hostel which is a girls home for 20 girls from the tribal area who without the home would have been on the street. The assistance provided for house rent, food, school material and other miscellaneous expenses necessary to keep the house operating.

For our other North India partnering organization in Odisha and West Bengal, Society for Transformation, Education and Progress, we provided 16 water projects benefiting an estimated 3,500 rural men, women and children. Additionally, we provided funding for two income generating projects as part of a plan to create some self sufficiency for the STEP partner and income for the program participants. A small investment was also made towards our partner for solar lights and a motor bike to create efficiencies for their campus and field workers operating the community development projects.

Provided 27 water projects within the East Godavari and Visakh Districts of Andhra Pradesh through our indigenous partners Nazareth Association for Social Awareness and Society for Helpless and Economically Backward Areas. These two partners work alongside each other and share synergies which makes them perfect partners for our efforts. The water projects benefit an estimated population of 15,000 rural men, women and children. We also carried out 7 medical camps benefiting 2,100 villagers and an emergency water camp in Tuni due to the extreme summer heat. Due to cyclone Hudhud emergency relief supplies in the form of water filters were also purchased and distributed along with funding to rebuild New Life Children's Home which sustained damage from the cyclone and provides education along with food and shelter to 200 children. A motor bike was also provided to the project manager for the fellow responsible for overseeing the water project work.
