THESE GRANTS SUPPORT THE PROGRAMS AND OPERATIONS OF MANY CHARITABLE ORGANIZATIONS IN THE LOCAL COMMUNITY AS WELL AS STUDENTS ATTENDING COLLEGE. DURING 2014, 350 GRANTS, TOTALING 3,796,567 WERE AWARDED TO 136 CHARITABLE ORGANIZATIONS. IN ADDITION, 426 SCHOLARSHIP GRANTS, TOTALING 411,150, WERE AWARDED TO LOCAL STUDENTS PURSUING A POST SECONDARY EDUCATION.
