In 2014, ACCESS's emergency shelter served 429 residents-203 women and 226 children. Approximately, 35,934 meals and snacks were served and approximately 12,000 nights of shelter were provided resulting in an average stay of 28 days per resident.

In 2014, ACCESS's Step II transitional shelter served 15 single, homeless adult females over the age of 18. A total of 2,388 bed nights were provided resulting in an average stay of 159 days per resident. 7,163 meals and snacks were served. Step II had 12 graduates in 2014.
