THE SISTERS OF CHARITY FOUNDATION OF CLEVELAND (FOUNDATION) CONTINUED ITS WORK WITH THE HOMELESS COMMUNITY BY EXPANDING ITS FOCUS ON PREVENTION AND ELIMINATION OF HOMELESSNESS AMONG THE YOUTH IN THE GREATER CLEVELAND AREA. THE FOUNDATION IS CURRENTLY COLLABORATING WITH THE CITY OF CLEVELAND AND THE CUYAHOGA COUNTY OFFICE ON HOMELESSNESS. AS THE GENERAL HOMELESS RATES DECREASE THE NUMBER OF HOMELESS YOUTH HAS BEEN RISING; THE FOUNDATION HAS ALSO BEEN A KEY PLAYER IN BRINGING TOGETHER COMMUNITY PARTNERS TO ADDRESS THIS ISSUE. ALONG SIDE THE ISSUE OF HOMELESSNESS THE FOUNDATION HAS TAKEN AN ACTIVE ROLE IN HEALTH ADVOCACY, AS ONCE THE ISSUE OF HOMELESSNESS IS ADDRESSED THE ACCESS TO HEALTH CARE PLAYS A VITAL ROLE IN HELPING THE HOMELESS MAINTAIN THEIR INDEPENDENCE.
