We found the perfect space for launching HatchLab in 2013, 13,000 sq. ft. of space, resources, allies, and experts to help make change worldwide. Our Hatch Grand Opening was held January 30, 2014, and nearly 200 people attended. HatchLab now offers 13 offices, ten cubes, and four Window Box desks, along with co-working space, conference rooms, cell phone booths, and 20+ workshops a month by local experts who provide their services free to Hatch members. We only lease to enterprises with missions to improve communities, whether locally or globally. We have attracted over 200 volunteers, professionals, community members, and students who come to meet like-minded people. Many more social entrepreneurs in the early stages have found Hatch to be a critical resource as they plan to launch change into the world. We have been in the black since March 2014, are fully leased at capacity with a waiting list. We've offered over 200 workshops on subjects from the basic such

as "What Kind of Entity Should I Be?" from a legal perspective to bigger questions about leadership, global impact versus local impact and diversity. We've invited national experts to speak at public events, sharing expertise on local investing and alternative finance and social innovation. We are frequently asked to host "World Affairs Council" groups to share our Hatch Lab model. We hold monthly "Hatch Community Gatherings" for our membership community with local experts, and have built a strong network around the world with other incubators and labs to share best practices.

Create new tools that grow community capital;

Our earlier on-line capital formation tool "ChangeXchange NW" was relaunched as "Hatch Oregon" with a new Oregon-only focus. Capital remains a key barrier to social enterprise, and small business, especially in rural parts of our country. In May 2014 we gathered a group of statewide business and community development leaders to explore the creation of a statewide crowd-funding law of our own, and after working collaboratively with our state's regulators and State Bar and many other agencies, in October we were told the law we had drafted was to be made into Administrative Rules, and would be LAW on January 15, 2015. Hatch Innovation began promoting this idea for alternative capital-community capital-across the state by speaking on panels and hosting events. We worked with ten companies to prepare them to launch the day the law was usable, and we launched with 9 companies offering local investments to ordinary Oregonians on January 22, 2015. This law is unprecedented in Oregon, and now allows 100% of Oregonians to become investors in social enterprise, small business, and innovations that improve our communities. Without Hatch Innovation, this law would not have happened.
