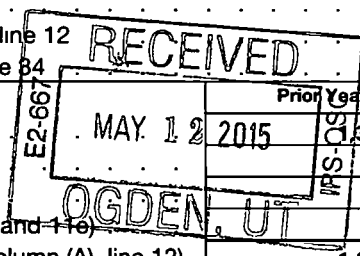

Madison Public Library is a publicly funded community resource offering lifelong learning and enrichment opportunities to people from cradle to grave, focusing on residents of the state of Ohio. Resources include informational and cultural materials, computers, and internet access, programs, classes and displays. Staff develop collections and programs to meet user needs and requests and assist users in locating and utilizing information.

Provide materials in a variety of formats(print,AV,electronic) for patrons to use in the library or at home to enrich their lives. Materials range from very simple for young children to complex, higher level information for advanced students and adults. Materials are borrowed to learn new skills or explore an area of interest. The majority of library staff and activities are devoted to this service. In 2014, the library circulated 571,785 items. Over 11,500 items were delivered to homebound patrons.

Another major line to business revolves around providing assistance for information seekers, including a place to do their work and use computers and Internet Access. In 2014, over 159,000 people used the library.

Significant resources are devoted to providing programs and classes to all ages of our public. These range babytime and toddler storytimes to programs on understanding and choosing Medicare supplements. On occasion, speakers are hired, but programs are primarily prepared and presented by staff members and volunteers. Other costs include advertising, overhead, and maintenance costs and office supplies related to or used in the program. In 2014, 1,489 programs were held in the library or presented by library staff with 20,338 attendees.
