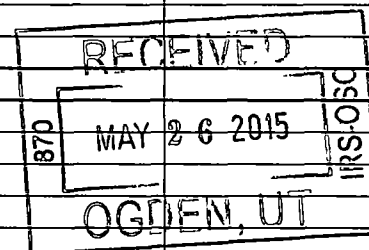

2. Scholarships, fellowships, and awards are generally made in the fields of chemistry and chemical and mechanical engineering at colleges and universities in the Midwest and Southwest, upon recommendation from the Scholarship Committee and determination by the Board. Student recipients are selected by the colleges and universities.
3. Charitable organizations to receive matching gifts are designated by employees, in accordance with established criteria.
