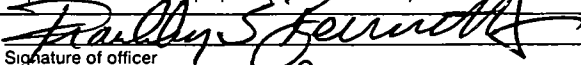

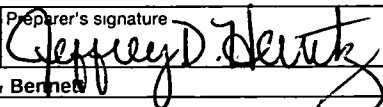

Part IV, Section D, Question 2: The Choffin Trust is a testamentary trust established by the Last Will and Testament of C. C. Choffin for the benefit of the Youngstown City School District for the purpose of maintaining, operating, and equipping the C.C. Choffin Career and Technical Center. The Choffin Trust is subject to the jurisdiction of the Mahoning County Probate Court, and the Court appoints all three trustees, who are the sole members of the governing body of the Choffin Trust. The Trustees maintain a close and continuous working relationship with the Youngstown City School District by meeting periodically with the director of the C. C Choffin Career and Technical Center and other staff members at the Choffin Career Center to review the equipment and financial needs of the Choffin Career Center and to review expenditures by the Choffin Career Center from the distributions made from the Trust.

Part V: The Choffin Trust is a testamentary trust created by the Last Will and Testament of C. C. Choffin at his death in 1957. No additional grant, contribution, bequest or other transfer has been received by Choffin Trust since its establishment. The governing instrument of the trust and a subsequent agreement approved by the probate court in 1962 require that all of the net income of the trust be distributed only to the Youngstown City School District for maintaining, operating and equipping the Choffin Career Center. The Trustees do not have discretion to change the beneficiary of the Trust or the amounts payable from the Trust to the beneficiary, other than the discretion to make principal distributions to the beneficiary. None of the Trustees are disqualified persons within the meaning of IRC §4946(a). The Trustees are required to file an annual accounting with the Mahoning County Probate Court. A copy of the annual accounting filed with the court, which contains a detailed list of the trust assets and the income produced, is provided to the Treasurer of the Youngstown City School District each year, along with a copy of the filed IRS Form 990.

and approved by the Trustees and then is submitted to the Mahoning County Probate Court for approval prior to payment to the
Trustees.
