IUPAT'S JOB CORP PROGRAM IS A COST REIMBURSEMENT CONTRACT WITH THE U.S. DEPARTMENT OF LABOR. THE IUPAT HAS BEEN INVOLVED IN JOB CORPS SINCE 1969 AND IS ONE OF FIVE BUILDING TRADES UNIONS OFFERING TRAINING PROGRAMS THROUGH JOB CORPS. TODAY, OUR UNION SPONSORS 46 JOB CORPS PROGRAMS IN 27 STATES. ALTHOUGH THE MAJORITY ARE FORTY (40) PAINTING PROGRAMS, THE IUPAT ALSO OFFERS TWO (2) FLOOR COVERING PROGRAMS, THREE (3) GLAZING PROGRAMS, ONE (1) SIGN AND DISPLAY PROGRAM. ALL IUPAT JOB CORPS PROGRAMS TAKE APPROXIMATELY ONE YEAR TO COMPLETE, AND CONSIST OF ON-THE-JOB TRAINING, SOCIAL SKILLS DEVELOPMENT AND GENERAL EDUCATION. STUDENTS MUST DO WELL IN ALL PARTS OF THE PROGRAM IN ORDER TO MEET THE REQUIREMENTS NECESSARY FOR ENTRY INTO AN APPRENTICESHIP PROGRAM. THE AMOUNT OF TIME SPENT IN GENERAL EDUCATION AND ON-THE-JOB TRAINING WILL DEPEND ON HOW HARD THE STUDENT WORKS AND ON THEIR EDUCATIONAL LEVEL AT THE TIME OF ENTRY INTO THE PROGRAM.
