Cancer Services provides direct services to people with cancer and their families living in northeast Indiana including practical help with tangible resources and emotional support. Practical help in 2014 included \$149,305 in financial assistance to help with cancer-related medical costs, 303 incidences of transportation assistance, 1,087 items of medical equipment loaned, 1,216 wigs and head coverings provided. 1,168 visits were made by clients to access personal health supplies such as bandages. Professional staff also provides information, referral and personalized advocacy regarding cancer and insurance, employment and financial matters. Client Advocates partner with physicians to provide personalized help for individual families. Professional staff and volunteers provide emotional support through support groups as well as one-to-one counseling. Cancer Services Advocates made 230 visits to homes, hospitals and treatment centers and served 2,579 local people with cancer and their families.

Education services are also provided to people with cancer and their families, medical professionals and interested community members through the Survivors Academy program. In 2014, Cancer Services hosted an Educational Symposium in collaboration with the Fort Wayne Medical Education Program and IUPUI, Fort Wayne titled "Small but Powerful Interventions: Positively Impacting Cancer Patient's Lives". This symposium was presented by Dan Shapiro, PHD, Chair, Department of Humanities, Penn State College of Medicine and was attended by more than 200 people. Registered Dietitians presented two nutrition seminars attended by 46 people and various programs provided information related to cancer and wellness. Additionally, a lending library of resource materials is maintained and volunteers staffed 28 health fairs in 2014 in workplaces and other community sites.
