SHULTS-LEWIS PROGRAM STAFF MET WITH THE FAMILY OF EACH RESIDENT ON A MONTHLY BASIS AND WITH EACH INDIVIDUAL RESIDENT ON A WEEKLY BASIS. GROUP SESSIONS WERE CONDUCTED THREE TO FIVE TIMES A WEEK. THE AGENCY ALSO OFFERS FOUR FAMILY WORKSHOPS EACH SEMESTER TO HELP EQUIP PARENTS OR GUARDIANS WITH FAMILY UNIFICATION.
