A NEW INITIATIVE CALLED "IT STARTS WITH YOU" THE PROJECT, LAUNCHED IN JANUARY 2011, IS AVAILABLE TO COUPLES AND SINGLES WHO ARE LOW-INCOME, UNMARRIED NEW AND EXPECTANT PARENTS WHO WISH TO STRENGTHEN THEIR RELATIONSHIP AND EXPLORE MARRIAGE POSSIBILITIES. A TOTAL OF 35 COUPLES AND 163 SINGLES COMPLETED THIS PROGRAM IN 2014.

FATHERHOOD DEVELOPMENT WORKSHOPS: OVER 300 MEN FINISHED AN INTENSIVE FIVE-WEEK TRAINING PROGRAM FOCUSING ON PARENTING, JOB READINESS, EDUCATION PREPARATION, RESPONSIBLE FATHERHOOD, SEXUAL RESPONSIBILITY AND OTHER LIFE SKILLS. THIS WORKSHOP HAS BEEN THE MAINSTAY OF THE CENTER. PARENTING CLASSES PROVIDE IMPORTANT INFORMATION NEEDED TO IMPROVE FATHERS' PARENTING SKILLS AND TO IMPROVE RELATIONSHIPS BETWEEN FATHERS AND THEIR CHILDREN. IN THE SESSIONS, FATHERS DEVELOP WRITTEN GOALS FOR REARING THEIR CHILDREN. THE INSTRUCTOR TEACHES APPROPRIATE EXPECTATIONS, CHILD HEALTH, SAFETY, WELLNESS INFORMATION AND APPROPRIATE DISCIPLINE METHODS. EMPLOYMENT PREPARATION SERVICES: BUILDING UPON AN ASSESSMENT OF PARTICIPANTS' PAST JOB HISTORY AS WELL AS PERSONAL AREAS OF INTEREST AND APTITUDE, THE CENTER'S WORKFORCE DEVELOPMENT MANAGER ASSISTS CLIENTS AS THEY PREPARE FOR EMPLOYMENT. FOCUS AREAS INCLUDE INTERVIEWING TECHNIQUES, RESUME PREPARATION, NETWORKING, AND CONDUCTING JOB SEARCHES.

IN INDIVIDUALIZED OR SMALL GROUP TUTORING SESSIONS, FATHERS AND FAMILIES OFFERS HSE PREPARATION SESSIONS THAT RUN DAILY DURING OFFICE HOURS. ON-SITE GED TESTING: FATHERS AND FAMILIES BEGAN COMPUTER-BASED HSE TESTING IN 2015 AT THE CENTER LOCATION THROUGH THE SERVICES OF OFFICIAL HSE TEST ADMINISTRATORS TO PROVIDE A COMFORTABLE AND FAMILIAR TESTING ENVIRONMENT FOR PARTICIPANTS. SCHOLARSHIP ASSISTANCE: THE CENTER'S EDUCATION ASSISTANT HELPS THOSE WHO HAVE COMPLETED HIGH SCHOOL OR HAVE THEIR HSE TO PREPARE FOR SCHOLARSHIPS AND OTHER FINANCIAL AID APPLICATIONS. HIGHER EDUCATION/VOCATIONAL TRAINING: ADVISING FOR THOSE WHO CONTEMPLATE FURTHERING THEIR EDUCATION, THE EDUCATION ASSISTANT WORKS TO PREPARE THEM FOR COLLEGE OR FOR VOCATIONAL TRAINING ALTERNATIVES. A TOTAL OF 26 MEN AND WOMEN PASSED THE HSE EXAM IN SEPTEMBER THROUGH DECEMBER 2014. THIS NUMBER WAS SUBSTANTIALLY LOWER THAN PREVIOUS YEARS BECAUSE OF THE SWITCHOVER FROM THE GED EXAM TO THE HSE FORMAT. HSE TESTING DID NOT BEGIN UNTIL SEPTEMBER.
