The organization conducts an annual survival education event at Tippecanoe River State Park. The organization rents the facilities including meeting halls, training rooms and housing cabins for participants. These cost are recovered through participation fees. And cabin rental fees. The funds are used to secure the facilities for the following year and develop programs. This is a public access program and often is attended by scout groups. Subjects include: first aid, edible wild plants, fire starting, outdoor safety, water purification, food preservation, alternative energy, fire starting, shelter building and direction finding.

The organization also puts on education programs at sporting goods stores, churches, community organizations and veterans groups. These programs are offered at no cost, but contributions and the sale (at discount) of preparedness related books support continued events. Subjects include: Family Preparedness 101, Survival Basics, Outdoor Safety, Pioneer Survival Techniques, Winter Survival at Home and Away, Home Canning, Gardening, Outdoor First Aid, and Hazard Awareness.

Publications and Educational Materials

The organization produces a variety of preparedness education flyers and handouts for distribution at various events. A semi-monthly newsletter is sent to members and often distributed free. This newsletter (American Survivor) is from 10-12 pages of preparedness and self-reliance how-to information and recommendations. DVD s are produced at our seminars and then sold to raise funds. The organization buys survival related books when available at reduced prices and resells them. These are sold at less than (marked) market price, but more than we paid. The website at www.americansurvivor.org contains a substantial amount of public access information on preparedness. Members can access additional publications and downloadable materials. Members help maintain the site, but we pay for hosting, and occasional upgrades
