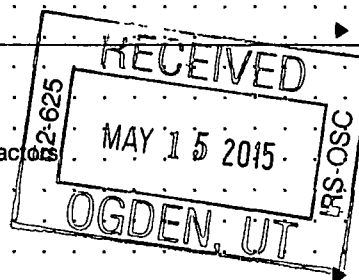



Part I, line 10. The \$115,000 grant was made to the Birdies for the Brave, part of the PGA Tour Charities, Inc. a 501-c-3 organization. This grant was then donated in its entirety to five charities as follows: Military Warrior Support Foundation, \$5,000; Special Operations Warrior Foundation, \$40,000; Operation Homefront, \$20,000; K9's for Warriors, \$40,000, and Troops First Foundation, \$10,000.

Part I, line 16. The major expenses included on line 16 include \$19,787 paid to Hampton Hall Club for use of the Hampton Hall Golf facilities and equipment plus an evening dinner for the participants of the charity event and auction. Additional expenses include \$5,942 for golf balls, hats, awards and expenses related directly to the golf participants and wounded heroes; Auction expenses of \$2,165; and \$1,828 in insurance costs. These items account for 86% of the total expenses shown on line 16.

Part III: The purpose of the Lowcountry Foundation for Wounded Military Heroes is to provide funds that directly support wounded warriors through charitable organizations like the Birdies for the Brave, part of the PGA Tour Charities, Inc. FEIN 59-2774423, a 501-c-3 organization. These programs are designed specifically for the individual needs of wounded warriors and their families as they assimilate back into the civilian population. Beneficiaries will include service members in the US Navy, US Army, US Marines, US Airforce and US Coast Guard. The Foundation's goal is to raise these funds via a Golf Tournament to be held at the Hampton Hall Golf Course on an annual basis.
